WORKLOAD

- Each thematic course will consist of 6-8 short video lectures lasting 10-15 minutes each (with transcripts and slide presentations).
- Video transcripts, slide presentations and course tests will be translated in all the ENP languages
- Total course duration up to 1.5 hours
- To complete the e-training, user will have to complete 7 knowledge courses and 3 skills courses
- Expected workload to finish 10 courses over 3 months: 1,5-2 hours per week

FINAL TESTS (Part I)

- Each course will be completed with online self-test
- Time required to take online test up to 2 hours
- Each E-Platform user will have 2 attempts to complete the test. The best scoring attempt will be taken into account when calculating the final ranking



FINAL TESTS (Part II)

- If the user completes more than 7 courses from the „Knowledge about the EU” group and/or more than 3 courses from the „Skills-building” group , only the highest marked 7 course scores from „Knowledge about the EU” group and 3 courses from the „Skills-building” group are taken into account in the total score.

TIME-SCHEDULE

E-Platform time-schedule is as follows:

- March 2016: Launch of the E-Platform
- 1 March : Registration for the courses opens
- 8 July 2016: Courses completed, tests submitted
- Late August 2016: Face-to-face sessions in Poland for 150 best performing E-Platform participants

FACE-TO-FACE SESSIONS

- Completion of 10 courses in total (7 knowledge-based and 3 skills-based) will make a participant (ENP national) eligible to be considered for participation in face-to-face sessions.
- 150 best performing participants (75 from ENP-East and 75 from ENP-South) will be invited, free-of-charge, to take part in face-to-face sessions/workshops which will take place in Poland in late August 2016.

LOGISTICS

- The *E-Platform* team will deal with logistics of face-to-face sessions
- Face-to-face sessions logistic arrangements will include travel reservations, visa assistance, accommodation (board and lodging) in Poland for the duration of the face-to-face sessions

INFORMATION DATABASE SYSTEM (IDS)

Information Database System (IDS) will collect systematised public information and documentation on the EU, ENP, EU-ENP relations, and best practices

ONLINE EXPERT FORUM

Expert Forum will enable participants' discussions with one another, as well as with practitioners and scholars working on, or interested in the European Union- and ENP-related matters for exchange of professional knowledge and experience
